

*Divergence in +/- indicators for percent/count change may indicate little overall change coupled with relatively wide annual fluctuation in case filings.

- On average, almost 44,000 cases were filed with the 11th Circuit Court and FCC each year.
 - Filings increased over the 5-yr period by about 1,200 each year.
- By count, the largest increases in filings were in associate civil/small claims, misdemeanor/etc. and domestic relations cases and with the FCC, while the largest decrease was in traffic/ordinance cases.
- Traffic/ordinance cases accounted for nearly one third of the court's caseload, while associate civil/small claims and misdemeanor/etc. accounted for approximately one-fifth each, and domestic relations for one-seventh (see below).
