FCC	Fine Collection Center
CDL	Commercial Drivers License impact. <i>See</i> CDL section for impact of serious traffic violation

## FINES FOR MISDEMEANORS AND INFRACTIONS

For a class A misdemeanor	not to exceed one thousand dollars;
For a class B misdemeanor	not to exceed five hundred dollars;
For a class C misdemeanor	not to exceed three hundred dollars;
For an infraction	not to exceed two hundred dollars.

## AUTHORIZED TERMS OF IMPRISONMENT

For a class A felony	a term of years not less than ten years and not to exceed thirty years, or life imprisonment;
For a class B felony	a term of years not less than five years and not to exceed fifteen years;
For a class C felony	a term of years not to exceed seven years;
For a class D felony	a term of years not to exceed four years;
For a class A misdemeanor	a term not to exceed one year;
For a class B misdemeanor	a term not to exceed six months;
For a class C misdemeanor	a term not to exceed fifteen days.

# **CHARGES**

**For any moving violation, as defined in Section 302.010 RSMo, or offense listed in Section 302.302 RSMo that occurs in a construction or work zone assess an additional fine of \$35.00 for a first offense and \$75.00 for a second or subsequent offense.**

**For any moving violation, as defined in Section 302.010 RSMo, or offense listed in Section 304.892 RSMo, (2013) that occurs in an active emergency zone assess an additional fine of \$35.00 for a first offense and \$75.00 for a second or subsequent offense.**

**For any speeding violation, as defined in Sections 304.009 or 304.010 RSMo, or passing violation, as defined in Section 304.892.3 RSMo, (2013) that occurs in an active emergency zone where responders are present assess an additional fine of \$250.00 for a first offense and \$300.00 for a second or subsequent offense.**

# **INFRACTIONS**

## INFRACTIONS SECTION 556.021 RSMo

- Infraction is not a crime, no jail time imposed
- Possible penalties include fine, court costs or forfeiture
- Filed by the Prosecuting Attorney or City Attorney
- No jury trial
- Process pursuant to Supreme Court Rule 19.08 for misdemeanor
- Burden of proof is “beyond reasonable doubt”
- Warrant may issue if party fails to appear
- Beginning January 1, 2012, civil enforcement of infractions is an option. This allows the PA to file infractions by civil action, allows for a default judgment for parties who do not appear instead of the issuance of a warrant; and decreased the burden of proof to a “preponderance of the evidence.” Collection of fines and costs through tax offset and debt collection will be available if a payment plan is established.
- “Infraction like” first offenses (fine only, no jail time) include:
  - Section 302.020 RSMo
    - Operate vehicle on highway without a valid license – first offense;
    - Operate motorcycle when driver’s license not validated for such operation – first offense;
    - Permit unvalidated licensee to operate motorcycle – first offense;
    - Operate vehicle with an instruction permit or license issued to another – first offense;
  - Section 302.321 RSMo
    - Driving while revoked/suspended – first offense;
  - Section 302.025 RSMo
    - As owner (or operator authorize another to) operate motor vehicle without maintaining financial responsibility;
    - Operate motor vehicle owned by another knowing owner of vehicle has not maintained financial responsibility;
  - Section 311.325 RSMo
    - Purchase/attempt to purchase or possession of liquor by minor – first offense;
    - Minor visibly intoxicated/blood alcohol content more than 0.2% - first offense;
  - The second violation of these offenses are then treated as misdemeanors with the possibility of jail time.

**PETITION FOR REVIEW (PFR)**  
**REFUSAL TO SUBMIT TO CHEMICAL TEST**  
SECTION 577.041 RSMo

**Required Statutory Findings:**

At a hearing the court shall determine only:

- (1) Whether or not the person was arrested or stopped;
- (2) Whether or not the officer had (as applicable for an adult OR a minor under 21 yrs. of age):
  - (a) reasonable grounds to believe that the person was driving a motor vehicle while in an intoxicated or drugged condition; or
  - (b) reasonable grounds to believe that the person stopped, being under the age of twenty-one years, was driving a motor vehicle with a blood alcohol content of two-hundredths of one percent or more by weight; or
  - (c) reasonable grounds to believe that the person stopped, being under the age of twenty-one years, was committing a violation of the traffic laws of the sate, or political subdivision of the state, and such officer had reasonable grounds to believe, after making such stop, that the person had a blood alcohol content of two-hundredths of one percent or greater; and
- (3) Whether or not the person refused to submit to the test.

The Director of Revenue is named as a necessary party as Respondent and served. Pending the hearing on the petition for review, a stay is permitted if the court, in its discretion, grants the stay. The court must send a copy of the stay to the Director. For a minor offender, an arrest for an intoxication-related offense is not required. The burden is on the Department and it proceeds first at hearing.

**Eligible for Limited Driving Privileges?**

Yes, on a first Refusal revocation, after serving 90 days of the revocation, if otherwise eligible. *Section 302.309.3(6),RSMo.*

### Reinstatement Requirements:

- ◆ SATOP
- ◆ SR-22 (proof of financial responsibility or insurance)
- ◆ **Ignition Interlock Device (IID)** Currently required only if offender has a prior Chemical Refusal. Effective March 3, 2014, IID required if offender has any prior “alcohol-related enforcement contacts” as defined in *Section 302.525.3, RSMo*. The IID must be maintained for a period of six months *from the date of license reinstatement*. License reinstatement triggers the commencement of the six-month period, not the “eligible for” reinstatement date.

### SATOP Assessment Review:

Once the offender’s license is suspended for a refusal, he/she must complete SATOP for license reinstatement. Once the SATOP assessment is complete, the offender may file a motion in the associate division of the circuit court of the county in which the assignment was given, on a printed form provided by the Office of State Courts Administrator (OSCA), to have the court hear and determine the motion pursuant to the provisions of chapter 517, RSMo. The motion must name the person or entity who made the SATOP assessment as Respondent and they must be served.

Upon hearing the motion, the court may, with the exception noted below, modify or waive any assignment recommendation that the court determines to be unwarranted based upon a review of the needs assessment, the person’s driving record, the circumstances surrounding the offense, and the likelihood of the person committing a like offense in the future. The exception is that the court may modify, but not waive, the assignment to an education or rehabilitation program of a person determined to be a prior or persistent offender as defined in *Section 577.023 RSMo*, or a person with a BAC of .15% or more. *Section 577.041.7, RSMo*.

**PETITION FOR REVIEW (PFR)**  
**ADMINISTRATIVE ALCOHOL TRIAL DE NOVO**  
SECTION 302.500 – 302.540 RSMo

**Required Statutory Findings:**

At hearing, the court shall determine only:

- (1) Whether or not the officer had probable cause to arrest for driving while intoxicated, and
- (2) Whether or not the subject was driving with a BAC of .08% or above.

For drivers under age 21 (minors subject to “zero tolerance”), with a BAC of .020% - .079%, the court shall determine only:

- (1) Whether or not the officer had probable cause to believe the subject violated a state, county or municipal traffic offense, and
- (2) Whether or not the subject was driving with a BAC of .02% or above.

The Director of Revenue is named as a necessary party as Respondent and served. Appeal must be filed in the county of arrest within 15 days of the date of mailing of the Department’s final hearing decision. Pending hearing on the petition for review, NO stay order is permitted. *Section 302.535.2, RSMo*. If otherwise eligible, a driver may be issued a Restricted Driving Privilege (RDP), valid during the pendency of the appeal. For a minor offender, an arrest for an intoxication-related offense is not required. The burden is on the Department at hearing. Appeal is de novo from the Department of Revenue administrative hearing, and is not a review of the record at hearing. The determination is independent of the adjudication of any criminal charges arising out of the same offense. Rules of civil procedure govern the trial de novo and the exclusionary rule is not applicable.

**Foundation for Admission of the Breath Test Result (19 CSR 25-30.010 – .060):**

To establish a prima facie foundation, the state must establish that the test was performed:

- 1) Following the approved procedures established by the Missouri Department of Health and Senior Services (DOHSS);
- 2) By an operator holding a valid permit issued by the DOHSS (Type II or III);
- 3) On a device approved by the DOHSS.

### **Eligible for Limited Driving Privileges?**

Yes, if otherwise eligible, after serving the first 30 days of a suspension or the first 45 days of a one-year revocation, and subject to required filings. *Section 302.309.3(f), RSMo, as amended July 5, 2013.* See page 81 for additional information.

### **Eligible for Restricted Driving Privileges?**

Yes, if otherwise eligible, after serving the first 30 days of a suspension, **OR** (effective October 1, 2013) after serving the first 15 days of a suspension, **OR** (effective March 4, 2014) after serving “0” days of the suspension. For requests for an “early” RDP on or after October 1, 2013, the driver (at his or her option) must affirmatively make a written request to the Department of Revenue, file proof of installation of an approved ignition interlock device (IID), and meet all other requirements. See page 78 for additional information.

NOTE: On and after October 1, 2013, the “early” RDP is at the option of the offender, and conditioned upon IID installation and monitoring requirements. First offenders remain eligible for issuance of a RDP without IID installation after 30 days if they do not select this option, and are otherwise eligible and meet requirements for issuance.

- ◆ **SR-22** (proof of financial responsibility or insurance) Not required for first-time .02 or above suspension for a minor.

The IID must be maintained for a period of six months *from the date of license reinstatement*. License reinstatement triggers the commencement of the six-month period, not the “eligible for” reinstatement date.

### **SATOP Assessment Review:**

The SATOP program in the state of Missouri is administered by the Department of Mental Health, Division of Behavioral Health. More information on SATOP providers, programs and requirements may be found at [www.dmh.mo.gov](http://www.dmh.mo.gov).

Once the offender's license is suspended or revoked, the subject must complete SATOP for license reinstatement. Following completion of the initial SATOP assessment, the offender *may* file a motion in the associate division of the circuit court of the county in which the assignment was given, on a printed form provided by the Office of State Courts Administrator (OSCA), to have the court hear and determine the motion pursuant to the provisions of chapter 517, RSMo. The motion must name the person or entity who made the SATOP assessment as Respondent and they must be served. The Department of Revenue is not a party to this action.

Upon hearing the motion, the court may, with the exception noted below, modify or waive any assignment recommendation that the court determines to be unwarranted based upon a review of the needs assessment, the person's driving record, the circumstances surrounding the offense, and the likelihood of the person committing a like offense in the future. The exception is that the court may modify, but not waive, the assignment to an education or rehabilitation program of a person determined to be a prior or persistent offender as defined in *Section 577.023 RSMo*, or a person with a BAC of .15% or more. *Section 302.540, RSMo*.

# COMMERCIAL DRIVER LICENSE

## SECTIONS 302.700 – 302.780 RSMo

**Commercial driver license (CDL):** *A driver license issued by this state to an individual which authorizes the individual to operate a commercial motor vehicle (Class A, B or C).*

**One License Only.** A person issued a Missouri CDL will be issued one license, which will indicate what class of commercial motor vehicle the person may operate (class A, B or C). The “one license” concept is based the premise that every driver has only one “state of record” for license issuance and for purposes of documenting their driving history. A CDL applicant must meet additional requirements over those required for a “base” driving privilege for class A, B or C commercial privileges. *Section 302.720 RSMo.*

A driver may have a “base driving privilege” (i.e., for operation of Class F or E vehicles) without a CDL, **but** a driver **can not** have a CDL without also having a base driving privilege. A CDL holder might lose his/her CDL privileges and retain the base driving privilege, but if suspended, revoked or denied for their base privilege, the CDL privileges are lost with it. *Section 302.705.1 RSMo.*

**Disqualification:** Defined as a suspension, revocation, cancellation or withdraw of a commercial driver license. The period of disqualification varies according to the type of offense and number of priors (see chart). *Section 302.700.2(10) RSMo.*

**“Conviction” for CDL disqualification is defined by Section 302.700.2(11) RSMo to include:**

- A plea of guilty
- A plea of nolo contendere
- A determination that a person has violated or failed to comply with the law in a court of original jurisdiction
- A determination that a person has violated or failed to comply with the law in an administrative proceeding
- An unvacated forfeiture of bail or collateral deposited to secure a person’s appearance in court
- The payment of a fine or court costs
- The violation of a condition of release without bail regardless of whether the penalty is rebated, suspended or prorated
- An offense for failure to appear or pay.

**NOTE:** *This varies from the definition of conviction for point assessment under Section 302.302 RSMo, and includes SIS dispositions, administrative outcomes (Administrative Alcohol and Chemical Refusal), bond forfeitures and failure to appear.*

**Courts are required to forward records of conviction within seven days of the date of conviction.** *Section 302.225 RSMo.*

## **CDL Disqualifications & Serious Traffic Violations**

“**Serious traffic violation**” is defined in *Section 302.700.2(30) RSMo* for CDL holders to include reckless driving, speeding 15 mph or more above the speed limit, improper or erratic lane changes, following too closely, and any moving violation relating to a fatal crash. Serious traffic violations also include driving a CMV without obtaining a CDL, driving a CMV without CDL in possession, driving a CMV without proper class of CDL or endorsement/restrictions, driving a CMV while texting and driving a CMV while using a hand-held mobile device (i.e. cell phone). **Note:** For a CDL holder, offenses committed in a CMV **or a non-CMV** (i.e., private vehicle), are used for CDL disqualification purposes, **if** the conviction for the offense committed in a private vehicle results in a suspension or revocation of the driver’s base driving privilege. *Section 302.700.2(30) RSMo*.

A **disqualification or out-of-service order** is a loss of only a driver’s commercial driving privileges (class A, B or C) for a specified period of time. During a disqualification or period of out-of-service (if the driver is not otherwise suspended or revoked), he or she can continue to drive private (noncommercial) motor vehicles without obtaining limited driving privileges. When a CDL is cancelled, the driver must wait until the disqualification period expires and then take the written and driving tests (this applies only when the disqualification period is one year or longer), and meet all other requirements of *Sections 302.700 to 302.780 RSMo* in order to get another CDL.

### **60 Day Disqualification**

- Two *serious traffic* violation convictions within three years if person is a CDL holder or if person is operating a CMV. **Note: The three-year period will be based on violation date rather than conviction date.**

### **120 Day Disqualification**

- Three or more *serious traffic* violation convictions within three years if person is a CDL holder or if person is operating a CMV. **Note: The three-year period will be based on violation date rather than conviction date.**
- Second railroad-highway grade crossing violation while person is operating a CMV.

### **180 Day Disqualification**

- First traffic conviction for violating an out-of-service order while person is operating a CMV.
- First traffic conviction for violating an out-of-service order while operating a CMV and transporting hazardous materials or transporting 15 passengers or more.

### **1 Year Disqualification**

- Driving any motor vehicle (commercial or noncommercial) while under the influence of alcohol or a controlled substance.
- Driving any motor vehicle (commercial or noncommercial), resulting in any “alcohol-related enforcement contact” as defined in Section 302.525.3 RSMo (including administrative license actions).
- Driving a CMV with a BAC of 0.04% or higher.
- Refusing blood and/or breath test if the person is a CDL holder or if person is operating a CMV.
- Leaving the scene of an accident.
- Using *any* motor vehicle (commercial or noncommercial) to commit a felony.
- Driving a CMV with a revoked, suspended, canceled, or disqualified privilege.
- Causing a fatality through the negligent or criminal operation of a CMV (includes the crimes of motor vehicle manslaughter, homicide by motor vehicle, and negligent homicide).
- Making a false statement on any application for a CDL.
- Third or subsequent railroad-highway grade crossing violation within three years while operating a CMV.

### **2 Year Disqualification**

- Second traffic conviction within ten years for driving a CMV while out-of- service.

### **3 Year Disqualification**

- First conviction for any one of the top eight violations for one- year disqualification if transporting hazardous materials.
- Third or subsequent conviction within ten years for violating out-of- service orders while operating a CMV.
- Second or subsequent conviction within ten years for violating an out- of-service order while operating a CMV and transporting hazardous materials or transporting 15 passengers or more.

### **Lifetime Disqualification**

(A 10-year minimum disqualification period in Missouri under 12 CSR 10-24.444)

- Second conviction for any one of the top eight violations listed under one-year disqualification.

### **Permanent Disqualification**

- First conviction for using a motor vehicle in the manufacture or illegal distribution of drugs.
- Convicted of any one of the top eight violations listed under one-year disqualification after restoration of a lifetime disqualification under 12 CSOR 10-24.444.

### **Imminent Hazard Disqualification (not to exceed one year)**

- Determination by the Federal Motor Carrier Safety Administration that a person's driving constitutes an imminent hazard.

### **NO Driver Improvement Programs (DIP) for CDL holders**

Driver improvement programs (DIP) will not be allowed by any person for any offenses committed in a CMV or by any CDL holder whether the offenses are committed in a noncommercial or commercial motor vehicle. *Section 302.302.5 RSMo.*

### **NO Limited Driving Privileges for CMV operation**

Limited Driving Privileges (LDP) will not be issued to operate a CMV during any period of suspension, revocation, cancellation, or disqualification. *Section 302.309.3(7) RSMo.*

### **CDL with School Bus Endorsement**

Persons who apply for a commercial or noncommercial driver license and want to operate a school bus owned or under contract with a public or private school will be required to complete the required written and skills testing and obtain a school bus (S) endorsement on his or her driver license. Prior to obtaining the S endorsement, the driver must obtain approval by meeting current medical, fingerprint based criminal records check, and child abuse and neglect registry checks. Pending the results of the criminal background checks, the driver may be eligible for a temporary license with the S endorsement. CDL holders are required to have a passenger (P) endorsement on the face of their CDL to be eligible for the S endorsement. *Sections 302.177 and 302.272 RSMo.*

Drivers with a valid CDL from another state who want to operate a school bus owned or under contract with a public or private school must also have the P and S endorsements issued pursuant to federal regulations. *Section 302.273 RSMo.*

### **Masking of Traffic Violations for CDL Drivers Not Allowed**

Courts are not permitted to defer imposition of sentence, suspend imposition of sentence, or allow a CDL holder or person required to have a CDL to enter into a diversion program that would prevent a conviction regarding traffic control laws, in any type of vehicle, from appearing on the person's driving record. *Section 302.345 RSMo; 49 CFR 384.226.*

### **What is considered “masking” under the Motor Carrier Safety Improvement Act (MCSIA)?**

The Missouri Department of Revenue requested clarification from the Federal Motor Carrier Safety Administration (FMCSA) regarding the masking provisions outlined in the Motor Carrier Safety Improvement Act.

**FMCSA:** Generally, for masking or diversion to occur, there first must be a judgment of guilt. For example, masking may occur when the court holds the paperwork on a conviction for some reason and does not allow the State to take appropriate action. Diversion may occur when the court allows a driver – after an adjudication of guilt – to perform alternate services to get the conviction erased.

**Situation #1:** CDL holder issued traffic citation for DWI in his private vehicle. Prosecutor reviews the records and determines that there is a problem with the evidence and decides not to prosecute the case, so no charges are filed with court. No conviction is entered.

**FMCSA Response:** No violation of 49 CFR §§ 383/384. The federal CDL regulations require a conviction as defined by §383.5. In this case, the evidence did not support the burden of proof to be properly adjudicated by the prosecutor and there were no excepted actions taken to otherwise circumvent the regulations (i.e., no masking or diversion of the offense or penalty).

**Situation #2:** CMV operator issued traffic citation for "Improper lane change in a CMV." Prior to the citation being filed with the court the prosecutor determines to only file the charge as a "defective muffler." Final conviction is for "defective muffler" and that is the only charge ever signed by the prosecutor or filed with the court.

**FMCSA Response:** This practice is not in violation of 49 CFR § 384.226 because the violation was reduced before a judgment of guilt was pronounced. Before we can apply the conditions in 49 CFR § 384.226 to determine whether masking has taken place, there has to be a judgment of guilt (conviction) for a violation. The masking provision in 49 CFR § 384.226 do not prevent plea bargaining from taking place.

**Situation #3:** CMV operator is issued a traffic citation for "Operating a CMV while Suspended/Revoked/ Withdrawn." Prosecutor files charges for "Operating CMV while license suspended/revoked/ withdrawn." Final conviction is for "Operating CMV while license suspended/revoked/withdrawn." Later, court allows attorney for CMV operator to withdraw original plea and conviction and after new court hearing, court ultimately enters a conviction for "Improper CDL Class/Endorsement."

**FMCSA Response:** This is not in violation of 49 CFR § 384.226 because the court vacated (withdrew) the original conviction or adjudication of guilt. By granting the attorney's request to vacate (withdraw) the original plea and conviction, the court has nullified the conviction. The definition of "conviction" in 49 CFR § 383.5 defines a conviction to mean "an unvacated adjudication of guilt."

## COURT-ORDERED LOSS OF LICENSE FOR ALCOHOL OR DRUG-RELATED OFFENSES

SECTIONS 577.500, 577.505 AND 577.510 RSMo

(REQUIRED TO BE ENTERED ON CONVICTION, PLEA OR FINDING OF GUILTY FOR THE FOLLOWING OFFENSES)

**MINORS** (under age 21 on date of offense):

### **Violation of Section 577.500.1 RSMo**

**1<sup>st</sup> Offense:** 90-day suspension

**2<sup>nd</sup> or subsequent Offense:** 1-year revocation

### **Offenses involving a minor and motor vehicle operation, including:**

(1) Alcohol-related traffic offenses—DWI, BAC (state law *and* municipal if represented by an attorney or written waiver).

(2) Possession or use of alcohol while operating a motor vehicle (state law *and* municipal if represented by attorney or waiver).

### **Offenses involving a minor with no vehicle operation, including:**

(1) Possession or use of a controlled substance (Chapter 195 RSMo), (state law *and* muni if represented by attorney or waiver).

(2) Alteration, modification or misrepresentation of a driver license (*Section 311.328 RSMo*).

(3) Possession or use of alcohol for a second time where a determination of guilt was made on the 1st offense; both offenses occurred while person under 18 years of age.

### **Violation of Section 577.500.2 RSMo**

(*Section 311.325 RSMo* **state law** “**Minor in Possession**” offenses only; offender age 16 to 20 years of age at time of offense)

**1st Offense:** 30-day suspension

**2<sup>nd</sup> Offense:** 90-day suspension

**3<sup>rd</sup> /subsequent:** One-year revocation

Applies to a minor more than 15 years of age and under 21 years of age who:

- Purchases or attempts to purchase any “intoxicating liquor” as defined in *Section 311.020 RSMo*;
- Has in his or her possession any intoxicating liquor;
- Who is in a “visibly intoxicated” condition as defined by *Section 577.001 RSMo*; or

- Has a BAC of more than .02% (“possession by consumption”).

**NOTE: There is currently no statutory authority to use county or municipal MIP ordinance violations for Abuse & Lose.**

### **Offenders less than 16 years of age:**

If an offender is 15 years of age or younger, the court is required to hold the order of suspension or revocation and forward to the Department of Revenue 30 days prior to the offender’s 16<sup>th</sup> birthday. The suspension or revocation will be assessed to commence on the offender’s 16<sup>th</sup> birthday. *Section 577.500.5(2), RSMo.*

**Expungement:** Expungement is only available under Section 311.326 RSMo for a Section 311.325 RSMo **state law** Minor in Possession offense (and resulting Section 577.500 RSMo Abuse and Lose action which was triggered by such conviction), *not* for a *Section 577.500 RSMo* Abuse and Lose action generally. Expungement is only available on or after an offender’s 22<sup>nd</sup> birthday (i.e., “period of not less than one year after reaching the age of twenty-one”), if otherwise qualified.

## **ADULTS (age 21 and over):**

**Section 577.505, RSMo** The court is required to order a revocation of the driver’s license for offenders twenty-one years of age or older at the time of offense, who is convicted, pleads or is found guilty of any offense involving the possession or use of a controlled substance, as defined in chapter 195, RSMo while operating a motor vehicle. The period of revocation for a first offense is one year.

## **Reinstatement Requirements (for both Minors and Adults):**

- ◆Pay \$45.00
- ◆File proof of SATOP completion

## **Eligible for Limited Driving Privilege? (for both Minors and Adults)**

Yes, if otherwise eligible and underlying offense is not a felony.

*Subject to major revision in 2014 legislative session.*

**Procedure for Priors - DWI (Section 577.023, RSMo)**

- Evidence presented or Defendant waives proof of facts
- Court makes findings of fact beyond a reasonable doubt
- Jury Trial – facts plead and proven outside hearing of jury prior to submission

# SUMMARY OF NEW IGNITION INTERLOCK DEVICE (IID) AND LIMITED DRIVING PRIVILEGE (LDP) PROVISIONS

\*\*\* SENATE BILLS 23 AND 480\*\*

STAGGERED EFFECTIVE DATES 2013 – 2014

Senate Bill 23 was passed in the 2013 Legislative Session. It amends Senate Bill 480, which was passed in the prior (2012) session. SB 480 has an October 1, 2013 effective date.

However, due to an apparent error in the repeal/reenactment language in SB 23, SB 480 contains provisions that will be effective only between the dates of October 1, 2013 and March 3, 2014. These cover restricted driving privileges (RDP) in *Sections 302.304 and 302.525, RSMo*, and certain license reinstatement requirements, *Sections 302.060, 302.304, and 302.525, RSMo*

Only section 302.309 limited driving privilege (LDP) provisions of SB 23 are effective July 5, 2013, the date Governor Nixon signed the bill; the remainder of the provisions will be effective March 4, 2014.

**NOTE:** On March 4, 2014, SB 23 will repeal and replace **all provisions of SB 480** relating to restricted driving privileges (RDP) and license reinstatement.

The timeline is as follows:

**July 5, 2013**—§ 302.309 LDP provisions *only* amended

**October 1, 2013**—§ 302.060 (5- and 10-yr. license denial reinstatement) and §§ 302.304 and 302.525 (“first” intoxication Point suspension and AD suspension restricted driving privilege (RDP) and reinstatement provisions amended.

**March 4, 2014**--§§302.060, 302.304, 302.325, 577.041. *RSMo*

SB 23 substantially impacts the requirement for Ignition Interlock Device (IID) installation for intoxication-related offenders, and revises provisions for license reinstatement and issuance of limited and restricted driving privileges.

Highlights include:

- ◆ Adds new camera and GPS requirement for 5-year and 10-year denial offenders, for LDP or reinstatement;
- ◆ Adds new ignition interlock device (IID) monitoring requirement for certain offenders;
- ◆ Imposes sanctions for IID “violations” committed during required IID installation period;
- ◆ Reduces or eliminates traditional “hard walk” suspension periods for LDP and RDP issuance, if IID installed;
- ◆ Will permit LDP issuance on Administrative Alcohol revocation actions after 45-day suspension;
- ◆ Will permit LDP issuance on a second or subsequent Chemical Refusal revocation, after 90-day suspension.

# IGNITION INTERLOCK DEVICE (IID)

**\*\*EFFECTIVE MARCH 4, 2014, SENATE BILL 23\*\***

CHAPTER 302 RSMo; SECTION 577.041 RSMo

**NOTE:** THIS SUMMARY IS A CUMULATIVE COMPILATION OF ALL 2013 REVISIONS TO DATE. MODOT RULES DEFINING A “VIOLATION” AND PROVIDING FOR THE IID MONITORING FUNCTION ARE NOT EXPECTED TO BE FINAL AND OPERATIONAL UNTIL EARLY 2014.

## **Restricted Driving Privileges (RDP)**

*Sections 302.304, 302.525, RSMo*

### **1<sup>st</sup> Point Suspension** (resulting from alcohol or drug offense)

*Section 302.304, RSMo*

### **1<sup>st</sup> Administrative Alcohol Suspension** (1<sup>st</sup> in five years)

*Section 302.525, RSMo*

- ◆ Option for a driver to obtain a RDP from day “one” (90-day RDP) *if* IID installed
- ◆ If the offender chooses this option, he or she must have no reported IID “violations reset” during the 90-day period of IID installation. If a violation is noted, the required period of RDP with IID installation is extended an additional 30 days.
- ◆ “Violations reset” as defined by MoDot Rule for ignition interlock monitoring purposes (*7 CSR 60-2.010(1)(A)37*)

## **Limited Driving Privileges (LDP)**

*Section 302.309, RSMo*

- ◆ Five-year limitation on LDP issuance repealed;
- ◆ Offenders now eligible for a LDP on Administrative Alcohol revocations, after 45-day “hard walk” *if* Ignition Interlock Device (IID) installed;
- ◆ Offenders now eligible for a LDP on a 2<sup>nd</sup> or subsequent Chemical Refusal revocation, after serving an initial 90-day “hard walk” suspension period, *if* Ignition Interlock Device (IID) installed (and otherwise eligible);
- ◆ “Two-Refusal” ineligibility for other LDP applicants has been eliminated;
- ◆ Ignition Interlock Device (IID) installation now required for 1<sup>st</sup> Chemical Refusal LDPs
- ◆ Ignition Interlock Device (IID) installation is required for LDPs for five- and ten-year denials; point revocation triggered by second intoxication-related offense; administrative alcohol revocation; and chemical refusal revocation.
- ◆ Camera and GPS features for IID required for five- and ten-year denial LDPs

## **Five- and Ten-Year Denial Limited Privileges**

*Section 302.309.3(8)(a) and (b) RSMo*

- ◆ Camera and GPS features on Ignition Interlock Device (IID) required for five- and ten-year LDPs.
- ◆ Eliminates two-year “hard walk” prior to LDP eligibility on five-year denial (now eligible from day “one”), with IID installation (subject to initial 30-day “hard-walk” suspension resulting from DWI or BAC conviction which triggered);
- ◆ Eliminates three-year “hard walk” prior to LDP eligibility on ten-year denial (0 days), with IID installation (subject to initial 30-day “hard walk” suspension resulting from DWI or BAC conviction which triggered);
- ◆ Eliminates requirement for criminal history checks for five- and ten-year denial LDP applications;
- ◆ Applicants must be “otherwise eligible” for a LDP under *Section 302.309 RSMo* (i.e., no felony, etc.). If not eligible, must apply to a DWI Court for LDP issuance.

New provisions require a court to (“*shall*”) grant the LDP if:

1. Applicant is otherwise eligible
2. Has filed proof of ignition interlock installation
3. Has no “alcohol-related enforcement contacts” since last conviction that triggered denial

However, the applicant must still present evidence *satisfactory to the court* that the person’s habits and conduct show they no longer pose a threat to the public safety.

## **License Reinstatement**

*Sections 302.060, 302.304, 302.525, and 577.041, RSMo*

### **Ignition Interlock Device Required for:**

**Point revocation**, with prior “alcohol-related enforcement contact” (as defined in § 302.525.3 RSMo) § 302.304.7, RSMo

**AD revocation or AD suspension**, with prior “alcohol-related enforcement contact” § 302.525.2(2), RSMo

**Chemical Refusal revocation**, with prior “alcohol-related enforcement contact” § 577.041.10, RSMo

**Five-Year Denial** § 302.060.1(10), RSMo (court shall order reinstatement, if otherwise qualified);

**Ten-Year Denial** § 302.060.1(9), RSMo (court shall order, reinstatement, if otherwise qualified)

◆ For **five- and ten- year reinstatement**--courts are required *to make a finding* as to whether the applicant’s habits and conduct show they no longer pose a threat to the public safety, and review results of a criminal history check (§ 302.060.3, RSMo). Camera and GPS features required on IID.

◆ All above reinstatements require ignition interlock device (IID) installation for a six-month period following date of license reinstatement (*not* date eligible for reinstatement).

◆ If any IID “violations reset” during the six-month period, an additional six-months of IID installation required

◆ “Violations reset” as defined by MoDot Rule for ignition interlock monitoring purposes (7 CSR 60-2.010(1)(A)37)

## **Court-Ordered Ignition Interlock**

*Section 577.600 RSMo*

- May order on first “intoxication-related traffic offense” as defined in *Section 577.023.1(4) RSMo*, upon plea or finding of guilt (includes SIS disposition);
- Court shall order on second or subsequent offense;
- Cost – Court may order fine be reduced by cost of device. *Section 577.602 RSMo*.

### **Minimum Period for Court-Ordered Ignition Interlock:**

Must require for a minimum six-month period from date of license reinstatement (not date *eligible* for reinstatement), whether or not the offender is currently eligible. The act of reinstatement commences the running of the six-month period.

### **Court-Ordered Interlock for Limited Driving Privilege:**

Where granted to applicant with second or subsequent intoxication-related offense, *must* require IID for term of LDP.

### **Proof of IID Installation with Department of Revenue (Administrative):**

Proof of installation of an IID upon conviction for certain alcohol-related offenses as a condition of license reinstatement **or** for the issuance of restricted or limited driving privileges for repeat offenders is required administratively. These provisions are in addition to the court-ordered requirements found in *Section 577.600 RSMo*. Installation is required for a minimum six-month period from the date of reinstatement.

A licensee is *required* to file proof of installation of an ignition interlock device with the Department of Revenue for:

### **Ignition Interlock Device (IID) “Violations Reset”**

(As defined by MoDot Rule, *7 CSR 60-2.010(1)(A)37*)

What the statutory provisions provide:

- Confirmed* BAC over setpoint of .025%
- Evidence of device tampering
- Evidence of device circumvention

As defined by MoDot Rule at *7 CSR 60-2.010(1)(A)37* as:

- A. Two 15-minute temporary lockouts within a 30-day period
- B. Any 3 refusals to provide a retest sample within a 30-day period
- C. Any 3 retest breath samples over .025% within a 30-day period
- D. Any attempts to circumvent or tamper with a device

◆ “Service reminder” on the IID device is activated on a “violations reset” event. Temporary device lockout results and driver is advised by the device to bring vehicle in to provider to reset. Violation is logged on monthly IID monitoring report.

NOTE: Proposed Rules anticipated to be filed September 2013, and final early 2014.

# LIMITED DRIVING PRIVILEGES (LDP)

**\*\*PROVISIONS EFFECTIVE JULY 5, 2013\*\***

SENATE BILL 23

SECTION 302.309 RSMo

## **NEW LDP PROVISIONS--OVERVIEW**

*Section 302.309, RSMo*

- ◆ Removes 5-year limitation on LDP issuance (i.e., repeals “one LDP in a five-year period” provisions);
- ◆ Offenders now eligible for a LDP on Administrative Alcohol revocation, after 45-day “hard walk” if Ignition Interlock Device (IID) installed;
- ◆ Offenders now eligible for a LDP on a 2<sup>nd</sup> or subsequent Chemical Refusal revocation, after serving an initial 90-day “hard walk” suspension;
- ◆ Eliminates “two-Refusal” ineligibility for other LDP applicants;
- ◆ Ignition Interlock Device (IID) installation now required for 1<sup>st</sup> Chemical Refusal LDPs

## **Five- and Ten-Year Denial LDP**

*Section 302.309.3(8)(a) and (b) RSMo*

- ◆ Camera and GPS features required for Ignition Interlock Device (IID)
- ◆ Eliminates two-year and three-year “hard walk” prior to LDP eligibility on five- and ten-year denials (now 0 days);
- ◆ Eliminates requirement for criminal history checks for five- and ten-year denial LDP applications;
- ◆ Applicants must be “otherwise eligible” for a LDP (i.e., no felony, etc.). If not eligible, may apply to a DWI Court.

A court “*shall*” grant the LDP if:

1. Applicant is otherwise eligible
2. Has filed proof of ignition interlock installation
3. Has no “alcohol-related enforcement contacts” as defined in § 302.525.3, *RSMo* since last conviction that triggered denial
4. Court makes finding that the applicant’s habits and conduct show they no longer pose a threat to the public safety

## **Limited Driving Privilege Requirements**

### **Chemical Refusal (1<sup>st</sup> or subsequent):**

Must serve first 90-days of revocation *Section 302.309.3(6)(e) RSMo*; file SR-22 and have proof of installation of Ignition Interlock Device (IID)

### **Administrative Alcohol:**

**1<sup>st</sup> offense (AD suspension)** Must serve first 30 days of suspension, with SR-22 and otherwise eligible. *Section 302.309.3(6)(f) RSMo.*

**2<sup>nd</sup> within five years (AD revocation)** Must serve first 45 days of revocation, with IID installation, SR-22, and otherwise eligible.  
*Section 302.309.3(6)(g) RSMo.*

### **DWI/BAC Point Suspension or Revocation:**

Must serve first 30 days of suspension or revocation *Section 302.309.3(6)(a) RSMo.*

### **License Denial (5- and 10-year):**

- ◆ Five (5) year denial - if otherwise eligible, with court order, SR-22, and IID installation with camera and GPS. *Section 302.309.3(8)(b) RSMo.*
- ◆ Ten (10) year denial - if otherwise eligible, with court order, SR-22, and IID installation with camera and GPS. *Section 302.309.3(8)(a) RSMo.*

### **LDP filing requirements** (*Section 302.309.3(3) RSMo*):

1. Must be filed in county of residence, employment, or principal place of business;
2. Most applications may be filed in Circuit Court or with Director of Revenue;
3. Five- and Ten-year denial applicants must file in Circuit Court;
4. Department of Revenue is a necessary party and must be named/served;
5. Must include SR-22 filing and a copy of driving record;

### **Scope of Operation for a LDP**

Limited privileges may be granted for the following purposes: (*Section 302.309.3(2) RSMo*)

- a) business, occupation or employment,
- b) seeking medical treatment,
- c) attending educational institution ,
- d) attending alcohol or drug treatment,
- e) seeking the required services of an Ignition Interlock provider, or
- f) other circumstance found to create an undue hardship on operator

Ignition Interlock Device (IID) installation is mandatory if second or subsequent intoxication-related offense (*Section 577.600.1 RSMo*).

**LDP applicants are ineligible for the following reasons:**

1. Too young (under 18 in commerce)
2. Too young (under 16)
3. Habitual alcoholic or drug user
4. Incapacitated person (adjudicated)
5. Anyone who has failed driver exam
6. Unsatisfied judgment (*Chapter 303*)
7. Failure to disclose identification after an accident
8. Conviction of involuntary manslaughter while DWI (*Section 565.024 RSMo*)
9. Out of state convictions (compact violations) or out of state violations
10. Conviction of any felony involving motor vehicle
11. Conviction for operating under influence of drugs
12. Leaving scene of accident (*Section 577.060 RSMo* offense)

**Ignition Interlock Required for LDP for:**

- One-Year Point revocation LDP (where revocation is the result of a second or subsequent “intoxication-related” conviction)
- Chemical Refusal LDP
- Administrative Alcohol Revocation LDP
- Five-Year and Ten-Year denial LDP
- 

**DWI Courts:**

A DWI court established under and which conforms with the requirements of *Section 478.007 RSMo* may grant an LDP to a driver who would otherwise be ineligible under the provisions of *Section 302.309.3(6) RSMo*. The driver must be a graduate of the DWI court or a participant for a minimum of 45 days. Is merely another form of court-ordered LDP, and the Director of Revenue remains a necessary party to the action. See Supreme Court Rule 26 for additional information and requirements contained in the Appendix section. Consult Local Rules, also.

# **DRIVER IMPROVEMENT PROGRAM**

## **SECTIONS 302.302 AND 476.385 RSMo**

- A court using the Fine Collection Center (FCC) may elect to have the FCC approve attendance at a Driver Improvement Program (DIP) or motorcycle-rider training course. A court does not have to authorize the FCC to approve DIP attendance. It is optional and up to the associate circuit judge or judges of each county.
- If a court chooses to authorize the FCC to approve a DIP on the court's behalf, the court must notify the FCC in writing by providing a court order directing the FCC to approve a DIP for all eligible violators who receive a moving violation traffic ticket from that county and those tickets are being processed by FCC.
- If a defendant is charged with a moving violation in a county that has authorized FCC to approve DIP, and they plead guilty and pay the fine and costs in full to FCC, the defendant will automatically be approved to attend an authorized DIP course to avoid having points assessed on their Missouri driver's license. Payment of the fine and costs through FCC is considered consent by the defendant to attendance at such programs.
- DIP is not available for a violation committed in a commercial motor vehicle or for any driver who has a commercial driver's license (CDL) from Missouri or any other state.
- Attendance at DIP is not mandatory. If a defendant chooses to attend DIP, they must complete an approved DIP course within 60 days of their guilty plea and must have the DIP program send proof of completion to the Missouri Department of Revenue (DOR), Driver License Bureau, P.O. Box 200, Jefferson City, MO 65105.
- No points will be assessed to the defendant's Missouri driver's records if they meet these requirements.
- If the violator does not complete the course within 60 days, the points will be assessed.
- For violations committed while operating a motorcycle, the defendant must attend an approved motorcycle-rider training course following the rules above to avoid point assessment.
- No defendant may attend the Driver Improvement Program to avoid point assessment more than one time in any 36 month period.
- Course completion certificates should be sent directly to the Missouri Department of Revenue, if a defendant receives one directly they should forward it to DOR.
- A DIP may be completed online, however, it must still be an approved program.

Genevieve, Sullivan, Vernon, Wayne, Worth, and Wright.

**Violation of the order prohibiting you from operating a vehicle that is not equipped with an ignition interlock device will result in the revocation of your driving privilege and you could be convicted of a class A misdemeanor, punishable for a term of imprisonment not to exceed one year.**

**Abuse and Lose - Minor in Possession  
Order of Suspension/Revocation Pursuant to Sections 311.325 and 577.500.2 RSMo**

The Court finds beyond a reasonable doubt that the above-named defendant/juvenile violated Section 311.325.1, RSMo. In addition, the Court finds that the defendant/juvenile was over fifteen (15) and under twenty-one (21) years of age at the time of the violation. 


